4. You may enter Pakistan by Air/Sea/Road. But the port of exit and mode of travel for your return journey will remain the same. However the person traveling by Air may exit from different airport with prior permission.
5. YOU MUST REPORT FOR POLICE REGISTRATION WITHIN 24 HRS. OF ENTRY IN PAKISTAN AND PRIOR TO DEPARTURE/ARRIVAL AT EACH SUBSEQUENT PLACE OF VISIT IN PAKISTAN.
