- ALL VISA FEES ARE NON-REFUNDABLE EVEN IF VISA IS DENIED.

Important:

- Make an [appointment](#) from website [cgpkchicago.org](#) before visiting the consulate. (appointment shall not set over phone).
- [Visa form](#) must be dully filled and signed by the applicant (In case of minor applicants, parents should sign). Contact details (cell number and email) must be clear.
- Please also mention expected/planned traveling date along with duration of stay in Pakistan on the visa form.
- Photograph should be with white background and stapled at rectangular box on top right side of page-1 of visa form.
- The validity of passport should be at least six (6) months.
- Please also attach the state ID/drivers license of the sponsor/inviter if he/she lives in US.
- In Case of applicant under 18 years of age attach the state ID or Driver's license of parents.
- Legal residential status in US means Alien registration card/Green card, work authorization card, F1 Visa etc.).
- The return envelope must be prepaid, self addressed and with tracking number.
- All visa processing times and duration are based on approval.
- Visa processing time for foreigner/Non-Pakistani citizens is 4-6 weeks.
- Mail visa application with all supporting documents at following address (if applying through mail).
